

Minutes of Branch Meeting November 6, 2025

Presentation by Brigham "Bo" Anderson PhD entitled "What is Artificial Intelligence: 3 + 1 things to know". The presentation was viewed by AAUW members from around the state via zoom, as well as members in attendance. Dr. Anderson discussed the different AI platforms, ChatGPT, GROK, Gemini. Recommended listening to Sam Altman, CEO of Open AI, for useful information about AI. He can be found on YouTube. Stated development of AI is simpler than anyone thought, will be coming sooner than what the media is saying and is safer than what the media is reporting. Reviewed the two distinct types of memory: Episodic and Semantic. Episodic Memory has a lower need for cognition, is used by influencers, and can be more prone to lies and errors. Semantic Memory is nonlinear, more logical and fact based. Involves analysis of experience and is better at detecting errors. These two styles have trouble talking to each other. Many good questions and discussions during the presentation.

Minutes of Board Meeting - November 19, 2025

President Viki Draper opened the meeting. Minutes: The minutes of the September Business Meeting were digitally distributed and approved.

TREASURY: Donna Loucks showed the approved budget and the amounts that have been spent to date. She asked for a motion to transfer \$6000 that has been held as a scholarship reserve for many years to WSWS. A motion was made and approved. The account balance as of November 19 is \$27,670.84. Some transportation bills for EYH have not yet been paid, but based on estimates, the cost of EYH will be close to \$3620. Donations in memory of Kathy Halsan have been a little over \$3,000. Donna created a way for people to make donations online using Zeffy.

EYH: Swede and Corene: 204 students attended, 56 of which were boys. In looking at the presenters' evaluations, their scores from 1-5 were rated from 4.0-4.8 and we had many return presenters. Teachers and school presentations produced the most attendees; posters were rarely mentioned. Parent Workshop had 14 parents attend. In the future, we will need a sign-in system for them and directions of where to go after the OMSI presentation. Additional information is available on Google Drive. There was excellent participation from AAUW members. We will have a regularly-scheduled business meeting on January 21 at 6:30 with the additional topic of having or not having EYH next year.

SCHOLARSHIP COMMITTEE: Nancy Kruger said she has received the first scholarship application for the 2025-2026 school year. Applications are now available on our website and are due by February 15. Last year we offered nine scholarships of \$2,000 each.

MEMBERSHIP: Cathy Cavness announced a membership get-together on December 13 at 1:00 p.m. at Mint City Coffee in Chehalis. Movers and Shakers will meet November 29 at noon, also at Mint City.


